

SKYJACKER CONSUMER REBATE INSTRUCTIONS

March 1st - May 31st, 2010

Skyjacker will be offering a **\$35.00** rebate on the sale of 4 Hydro or Nitro shocks or a Skyjacker leveling kit and 2 Skyjacker Hydro or Nitro shocks to the retail consumer from March 1st through May 31st 2010. Enclosed is a rebate counter top display with link to download rebate redemption forms and poster.

Display these in your store during the rebate promotion period and watch your sales increase. If you need additional in-store rebate displays, or posters log on to skyjacker.com/shockrebate to order.

HERE'S HOW THE REBATE WORKS

- 1: Sell your retail customer 4 Skyjacker Hydro or Nitro Shocks or a Skyjacker Leveling kit and 2 Skyjacker Hydro or Nitro shocks during the rebate promotion period (March 1st through May 31st 2010).
- 2: Give your customer their receipt.
- 3: Tell your customer to fill out the redemption form that you or your customer can download from our rebate website skyjacker.com/shockrebate.

That's all you need to do. There is no waiting for months to be reimbursed for a free shock that you gave away, no paperwork for you to fill out. You sell your customer 4 shocks (not 3), and the **\$35.00** cash back is sent to the consumer directly from Skyjacker.

If you are installing these shocks and leveling kits, please remember to save the boxes and give them to your customer. They will need the flaps from all of the boxes showing the UPC symbol and part number to redeem their \$35.00 rebate.

HERE'S HOW THE RETAIL CONSUMER REDEEM'S THEIR \$35.00 REBATE

Your customer sends in a completed rebate form with a clean clear copy of the original receipt and the flaps from all the boxes showing the UPC symbol and part numbers to:

Skyjacker will send a check to the consumer for **\$35.00**. All material must be sent in one envelope and the envelope must be postmarked no later than June 30th 2010 in order to qualify. Please allow 6-8 weeks for receipt of the rebate check.

Skyjacker has launched a major consumer ad campaign to promote this shock rebate. Be sure that you stock up on your Hydro and Nitro shock inventory and leveling kits so you have them on your shelf for the spring season and this promotion; you will see a big increase in demand with this rebate.

Note: The materials and information listed are required to process rebate and must be sent together in one envelop. Failure to submit any items listed above will prevent rebate payment. Envelope must be postmarked no later than June 30, 2010. Offer is limited to one rebate per person or household.
